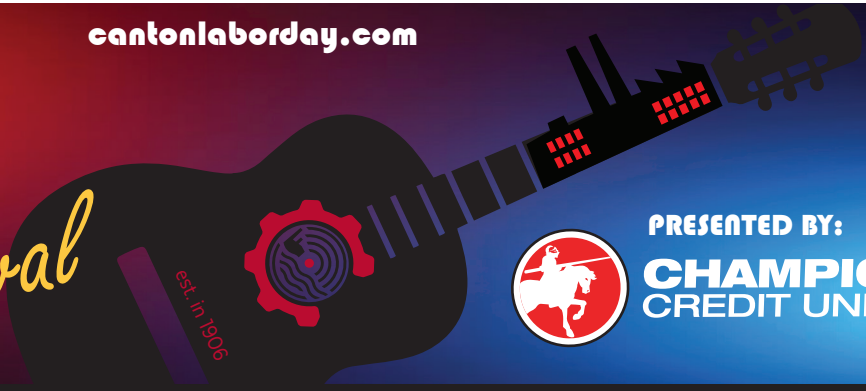

#### FOR PROFITS:

(Must supply your own generators)

**RATE: \$200.00 Total (\$100.00 per day)**

Food vendors must provide a current Certificate of Liability Insurance at time of application. Applications will be refused if proof of liability insurance is not provided. The following is required:

**COMMERCIAL GENERAL LIABILITY COVERAGE:** Must be on an occurrence form containing limits of at least \$1,000,000 per occurrence/\$1,000,000 general aggregate/ \$1,000,000 products-completed operations protecting claims arising from the exposure of:

1. Premises or Ongoing Operations.
2. Products-Completed Operations: This coverage must be maintained through the statute of limitations in the state where the work is being performed. Policies and/or endorsements cannot include any provisions that terminate products-completed operations coverage at the end of the policy period or limit this coverage in any other way with respect to the additional insured.
3. Independent Contractors.  
Contractual Liability coverage

**COMMERCIAL GENERAL LIABILITY COVERAGE** must contain the following provisions:

1. This coverage must be primary and non-contributory; contractor's insurance shall be considered excess for the purpose of responding to claims.
2. The Town of Canton must be listed as Certificate Holder and Additional Insured in respects to the general liability policy.

**SETUP:**

1. The festival begins at 10:00am and ends at 10:00pm.
2. Setup begins at 7:00am and **MUST be completed by 9:00am**. Please refrain from packing your booth until after 10:00pm. Saturday set-up arrangements can be made.
3. **\*\* Please note the Town will provide overnight security so you may leave your set-up in place and you must be in your vendor areas on Monday no later than **9:00am** due to parade traffic and street closures. \*\***

You will be allowed to setup and sell food at Sorrells Street Park area on Sunday and Monday, September 3&4, 2023 only. All vendors cooking food must provide a fire extinguisher in some form;

- Your truck, signs, equipment, tables, chairs, etc. are your responsibility;
- You as a food vendor will be required to be inspected by the Health Department Inspection if necessary;
- The Town of Canton and Canton Labor Day Committee makes no guarantee of revenue/profit for your participation in this event; &
- In the event that any of the Labor Day Festival Events are canceled, any and all payments paid are non-refundable.

**TAXES:**

Each exhibitor is responsible for collecting and reporting 7% sales tax. Remit to:
